- We are not open on public holidays.

- Should the schools close early on any given day/days, additional charges might apply for hours over and above the charges as indicated above.
- Arrangements must be made with the aftercare center should an alternative adult fetch the child/ren.
- Learners are supervised and assisted when doing homework.
- Any speeches and tasks need to be done at home. We will listen and help them practice their speeches.
- Please note that a late pickup penalty fee of R50.00 per hour or part thereof, will apply for parents arriving more than 5 minutes late.
- It remains the responsibility of the parents to inform the aftercare should a child not be present on any particular day.
- Lunch: We are in the process of establishing a tuck shop where lunches will be available to purchase. Until this service is available, lunch boxes, snacks and cool drinks must be packed for your child.

TERMS & CONDITIONS

- All payments are monthly in advance.
- All payments are due by the 3rd of each month.
- We require 1 calendar month's notice for termination of service.
- A R50.00 penalty fee will be charged for any payments received after the 3rd of each month.
- Your child will not be allowed at aftercare until payment is received in full for overdue accounts.
